Whereas, the District Panchayat Election Officer (Deputy Commissioner) Kupwara vide letter No:- DEOK/Pyt/2018/4385-4391 dated :- 03.11.2018 has reported to Chief Electoral Officer J&K Jammu regarding de-notifying of Panch Ward No :- VI of Panchayat Halqa Rashanpora-A in Block Meelyal District Kupwara copy of which endorsed to this office as well, in view of report submitted by Tehsildar Kralpora vide letter No :- TK/OQ/18/411 dated :- 03.11.2018 to his office wherein Tehsildar Kralpora has stated that the families residing in Mohalla Jabdi Ward No VI actually belong to the caste of Lohar, which has been changed into Awan by virtue of mutation No. 507 of village Rashanpora and that no any family from said panch constituency belongs to ST community.

Whereas, District Panchayat Officer Kupwara vide his letter No: -DPO/K/Pyt/2018/1124-77 dated: -03.11.2018, has also reproduced the report of Tehsildar Kralpora as reflected above and has recommended that the Panch Ward No. VI of Panchayat Halqa Rashanpora A may be un-reserved.

Whereas, the office records of this Directorate reveal that the District Panchayat Officer Kupwara vide his No :-DPO/K/3496-97 dated :-30-12-2017 had forwarded the verified reservation in respect of Panch constituencies of all Panchayat Halqas of District Kupwara, which include the instant Panch constituency PC-VI Rashanpora A which has been shown as ST reserved.

Whereas, on the basis of the above mentioned report of District Panchayat Officer Kupwara, this office had framed the reservation of panch constituencies accordingly and the draft notification dated:- 30.12.2017 for reservation of SC/ST/Women &ST Panch constituencies was published through Information Department in the Daily Aftab in its edition dated 03.01.2018 for inviting objections / suggestion from the general public within a period of 7 days.

Whereas, no objection was received within the prescribed time from the inhabitants of the area and accordingly this office had issued the final notification vide notification No :- 2 DRDK of 2018 dated :- 10.01.2018 for reservation of Panch constituencies for SC/ST/Women & ST which includes the Ward No VI of Panchayat Halqa Rashanpora A.
