Whereas, in the said order it was ordered that the candidates who fail to join within a period of 21 (twenty one) days of the issuance of the said order shall forfeit right to their appointment which shall be cancelled forthwith;

Whereas, the above named candidate have failed to join in the office of Project Officer Wage Employment (ACD) Shopian within the prescribed time limit as reported by the POWE (ACD) Shopian vide letter No. CD/Spn/14/3885+86 dated 30-12-2014;

Whereas, the above named candidates were provide last opportunity to report/ join in the office of Project Officer Wage Employment (ACD) Shopian under notice bearing No. DRDK/Estt/Shopian/SSR/Gnl/14/23386-91 dated 24-01-2015, which was published in the Daily News Papers through Information Department, but none of the candidate supra have joined till date, therefore as per norms candidates from the waitlist, in accordance with the category-wise shortfall, are to be appointed and appointment order issued in favour of the above named candidates who failed to join needs to be cancelled;

Now therefore it is hereby ordered that:-

1. Appointment order issued in favour of the candidates mentioned at S.No 1 to 23 supra is cancelled *abi-intio*.
2. sanction is hereby accorded to the temporary appointment of following candidates against the posts of Village Level Workers district cadre Shopian in the pay scale of Rs. 5200-20200 ( Grade Pay Rs.1900) with immediate effect.

The appointees shall be on probation for a period of two years as prescribed under rules.

The candidates shall report to Project Officer Wage Employment (ACD) Shopian who shall allow them to join only after production of the following certificates/documents in original:-

1. Qualification certificates/Marks Certificates.
2. Date of birth certificate.
3. Physical fitness certificate.
4. Permanent residence certificate.
5. Certificate from the District Employment Officer and District Industries Centre concerned to the effect that No loan under self-employment has been taken.
6. Character certificate from the competent authority.
7. Relevant category certificate.
8. An undertaking in the form of affidavit as given in Annexure-I duly attested by judicial magistrate
9. Any other certificate required under rules.

The candidates shall also bring Photostat set of all the above documents duly attested by a Gazetted Officer along-with at the time of joining.

The salary of the appointees shall be drawn and disbursed to them by the concerned DDO after receipt of the verification report from the verifying agency, Viz. CID and concerned University / Board.

In case any candidate is adversely reported upon by the verifying agency viz. CID or the relevant category or other certificate is found not be genuine/ valid, he/she shall have no claim to hold the post to which appointed and his/her appointment shall automatically stand cancelled without any further notice and shall be liable for criminal proceedings.

Any candidate who fails to join within a period of 21 (twenty one) days from the issuance of this order shall forfeit his/her right to the appointment which shall be cancelled forthwith.
