- 7. No further release of funds shall be made unless the monthly expenditure the drawal expenditure statement is regulated by 6th of the following month in this Directorate.
- 8. The DDO shall ensure that no salaries are paid to the new plan creation post of VLWs/AD Plainning out of this releases for which separate release shall be made after compilation of Plan Revenue Budget towards Non-Plan.
