- 7. The Utilization Certificate/Update Expenditure be furnished immediately after the expenditure is booked regularly forwarded by the 10<sup>th</sup> of the following month in this Directorate for monitoring the expenditure.

- 8. The funds are not diverted from one unit of appropriation to any other and shall not exceed under any circumstances.
- 9. The funds shall be utilized purely for drawal of salaries of regular and genuine employees against sanction strength of the posts.
