  whose cases are sub-judice before court of law/other forums.
- The monthly expenditure /drawal statement shall be submitted to this directorate by or before 5<sup>th</sup> of succeeding month from the DPOs of Districts timely received from BDOs.
- the funds are not diverted from one unit of appropriation to another and shall not exceed under any circumstances
