**ORDER No. 128- DRDK of 2016**

Pursuant to the release of funds made by the Chief Engineer Kashmir PHE Department Srinagar vide above referred order, sanction is hereby accorded to the release of funds to the tune of **Rs 22.897 lacs (Rupees twenty two lacs eighty nine thousand seven hundred only)** under Major Head 2215- Water Supply and Sanitation ( Non- Plan) in favour the District Panchayat Officers for further placement to the BDO's as per the order forming annexure "A" against the work done claims of Executive Engineer PHE Ground Water Division Srinagar on account of repairs of Hand Pumps / Wells executed in different constituencies as endorsed by the Chief Engineer Kashmir PHE Department Srinagar vide letter No. PHE/Wks/HP/861/30938-41 dated: 04-01-2016.

The funds be utilized subject to the following conditions:-

1. That the works has been conducted & verified through Halqa Pyt. Committees.
2. That the payment be made after due verification of the particulars of claim.
3. That the payment be made against the work done claims
4. That the allotment of funds is only an "Act of appropriation" and it should be ensured that the expenditure is supported by the "Act of Sanction" by the competent authority.
5. The expenditure should be incurred only after the Approval of Action plan by the PHE Department and strictly as per instructions contained in Government order No: 269-F of 2011 dated; 23-11-2011 issued by Finance Department and order N; 207-F PW(Hyd) of 2012 dated: 22-05-2012 issued by PHE, I&FC Department.
6. The austerity invoked in terms of Govt. Order No: 273-F of 2009 dated: 7-12-2009 shall continue to remain in force for the year 2015-16 as well
7. That the works which the expenditure is incurred are administratively approved and technically sanction by the competent authority.
8. That the allotment of funds shall not be construed as an approval/ authority for incurring od any expenditure in violation of rules and the Govt orders/ instructions issued by Govt. in Finance Department, Administrative Department and orders issued by this office from time to time and other required formalities are fulfilled.
9. That the funds are not diverted from one unit of appropriation to another and no case shall exceed the budget grants.
