The release order of funds is subject to fulfillment of following terms and conditions:-

- 1. The allotment of funds should not be construed as an authority/approval for incurring of any expenditure in violation of codal provision, financial rules and instructions issued by Government from time to time.
- 2. In case of releasing remuneration to Panchs ,wherever a claim for two sittings per month is made, the Panchayat Secretary shall certify that the two or more meetings have taken place along with the certificate appended with the copy of minutes of the two meetings which shall be duly signed by the Panchayat Secretary and the Sarpanch /Panchs. The Block Development Officer shall release the amount to the Sarpanchs & Panchs on the basis of these certificates.

- 3. The DDO will ensure that no remuneration/sitting fee is drawn in favour of the Sarpanchs/ Panchs whose cases are sub-judice before court of law/other forums.
- 4. The monthly expenditure /drawal statement shall be submitted to this directorate by or before 5th of succeeding month from the DPOs of Districts timely received from BDOs.
- 5. The funds are not diverted from one unit of appropriation to another and shall not exceed under any circumstances.
- 6. That the funds are released for clearance of pending remuneration arrears for the year 2014-15 which has been not drawn. The DDO shall certify upon the face of bills that the amount has not been drawn from the Treasury sofar.
