- The financial rules/ orders by the Government/ Finance Department from time to time shall be observed while incurring expenditure against allocation.
- 7. Administrative Approval/ Technical Sanction where ever required should not only be sought, but be obtained before the expenditure is incurred.
- 8. The work shall be executed after observing all codal formalities.
