**ORDER NO. 1171- DRDK of 2016**

**Dated: 22 -08 -2016**

Sanction is hereby accorded to the release of **revalidated amount of funds** to the tune of **Rs.624.27 lacs (Rupees Six crores twenty four lacs twenty seven thousand )** only under 13<sup>th</sup> Finance Commission Award (13<sup>th</sup> FC) in favour of **Project Officer Wage Employment (ACD)** as per **Annexure-A** to this order for **"Flood Protection related works"** for it's utilization during 2016-17 under 13<sup>th</sup> Finance Commission Award- Performance Grant.

**The release of the above funds is subject to fulfillment of the following conditions which should be adhered to strictly in letter and spirit:-**

1. That the funds be utilized only after proper estimation/scrutinizing of estimates, Accord of Administrative Approval/Technical Sanction etc. from the Competent Authority and violation if any shall be the personal responsibility of DDO/Implementing Executing Agency concerned.
2. That the Expenditure shall be incurred only after observing all Codal procedures/formalities to ensure financial discipline.
3. That the funds are not available /meant for any kind of re-appropriation/diversion at any level without prior approval from the Competent Authority/Administrative Department.
4. That only most vulnerable spots which have faced devastating floods in 2014 and even after wards need to be protected from floods by way of constructing Gabions/ Flood Protection Bunds as per MGNREGA guidelines, are to be taken up for execution.
5. That no small works at Panchayat or Block level need to be taken ju: *Continued overleaf on P-2* <sup>AN</sup> below level.
6. That the major works which are to be identified should not to be restricted to Block or Panchayat Halqa but identified at district level as to have cushion of maintaining 60:40 ratio under MGNREGA.
7. That the work(s) should be identified at District level in consultation with concerned District officers and should not be left to Junior Block Level Officers / Officials at Block or Panchayat level.
8. That in every District not more than three to four works should be taken for which the basis should be flood devastation or areas prone to frequent floods.
9. That the financial rules/orders issued by the Government/Finance Department from time to time shall be observed while incurring expenditure against allocation.
10. The Executing agency will ensure that the Administrative Approval /Technical Sanction wherever required is not only sought but should obtain the same before incurring the expenditure against the approved work(s).
11. That the Executing Agency /ACD will ensure that Monthly Progress Report (MPR) both Physical and Financial (component-wise) is submitted to Directorate of Rural Development Kashmir by or before 5th of every succeeding month on regular basis without fail.
12. That the concerned Implementing Agency shall ensure that the payments are made only after verifying the work(s) physically existing on ground.
13. That the Implementing agency shall ensure that the work(s) were not executed by any other Agency viz. I&FC Deptt. / IWMP etc. prior to this and may also ensure submission of photographs

of the instant work(s) showing the same prior to its execution, during execution and after execution for record and reference to avoid any duplicity of the Same.


