 - The work shall be completed as per the prescribed timeline conveyed to Divisional Commissioner during the review meeting held in the District.
 - 7. That the work/project is completed both physically/financially within the prescribed time schedule and within the approved estimated cost to avoid any cost escalation and deviations, if any shall be the personal responsibility of the implementing Agency.
 - That the proposal is strictly devised and designated as per the relevant code of BIS/CPWD/IRC/MORTH Manual /specification.

That the rates incorporated in the estimate other than allotted one should be properly analyzed, by Competent Authority for the lowest market rates and the Executive Engineer (REW) / paying authority concerned shall be responsible for its reasonability. Besides, the concerned may also ensure that they will strictly adhere to the lowest rates which have been adopted and will go by the same while framing the bills/releasing, the payments to the executing agency and deviations if any, shall be the personal responsibility of the implementing agency.
