- 9. That the rates incorporated in the estimate other than allotted one should be properly analyzed by Competent Authority for the lowest market rates and the Executive Engineer (REW) / paying authority concerned shall be responsible for its reasonability. Besides, the concerned may also ensure that they will strictly adhere to the lowest rates which have been adopted and will go by the same while framing the bills/releasing, the payments to the executing agencies and deviations if any, shall be the personal responsibility of the implementing agency.
