8. DDO's shall strictly inspect and supervise the public receipts and expenditure with references to the

Appropriation Act.2015 and all the standing rules and regulations.

9. All the Sanctions /approvals and clearance shall be in place before drawal of money from the Treasury.

10. Funds under salary/Wages /Honorarium and Remunerations for those who have been appointed by the competent authority.
