C I R C U L A R

It has been brought into the notice of undersigned that some Govt. vehicles of different departments are without registration or having incomplete documents besides, the officials who use bikes of the departments do not wear protective head gear (Helmet) which is total violation of Motor Vehicles Act.

It is as such enjoined upon all the HoDs to direct the concerned officials to strictly adhere to the Motor Vehicle Act/Rules and ensure that no vehicle is plied on roads without registration plate or incomplete documents. Moreover, the bikers of the departments be also directed to wear protective head gear (Helmet) during official duty.

Any violation of these circular instructions shall be taken serious note of by the Competent authority and guilty shall be taken to task as per the relevant law/rules.
