Whereas, this office issued notification vide No: - DRDK/Pyt/Elec/Gnl/24413-21 dated:-14.08.2018 for draft proposal of de-notification of panch ward No VIII of Panchayat Halqa Shankerpora Block B.K Pora District Budgam for inviting objection from general public if any within a period of Five (05) days from the publication of draft proposal notice i.e. 17.08.2018 to 21.08.2018 for de-notification of panch ward No VIII of Panchayat Halqa Shankerpora Block B.K Pora District Budgam.

Therefore, in view of the above and in exercise of powers vested under Sub-Section 3 of Section 4 of J&K Panchayati Raj Act 1989 amended upto March 2016 and as per J&K Panchayati Raj Rules 1996 under Rule 4 of Chapter II, I Director Rural Development Kashmir hereby de-notify panch ward No VIII of Panchayat Halqa Shankerpora Block B.K Pora District Budgam. Therefore the Panch ward No 09(Nine) shall be figuring and read as Panch Ward No.8(Eight).
