Draft Proposal for de-notification of Panch ward No:- VIII (Eight) of Panchayat Halqa Shankerpora Block B. K Pora District Budgam.

NOTICE FOR GENERAL PUBLIC

Whereas, the District Panchayat Officer Budgam communicated to District Election Officer Budgam vide his letter No: - DPO/Bud/Pyt-Election/11121-24 dated: - 23.07.2018, copy of the same has been endorsed to this office as well mentioning therein that the voters of constituency – II (Two) to Constituency-VII (Seven) were partially transferred to Srinagar Municipal Corporation and Constituency-VIII was entirely transferred from Panchayat Halqa Shankerpora vide SRO-219 dated:- 29.06.2016.

Whereas, the District Panchayat Office Budgam has further communicated that as per the Gazette notification published by Directorate of Rural Development Department, the area falls in Rural jurisdiction and recently all the voters of said halqa have been marked as Municipal Voters leaving the Halqa Shankerpora without voters and the voters belonging to Panchayat Halqa Shankerpora which has been marked in Urban Area due to over sight may be unmarked in Rural Area.

Whereas, the matter was taken up with the Administrative Department by this office vide letter No: - DRDK/Pyt/Elc/17753-56 dated: - 25.07.2018 for taking up necessary action in the matter at an earliest.

Whereas, the District Election Officer Budgam communicated to this Directorate vide letter No: -DEO/Bud/2018/470-74 dated: -10.08.2018, that the panch ward wise marking of rural voters of panchayat Halqa Shankerpora Block B. K Pora falling under the rural limits has been done as per the proposal submitted by the concerned field functionaries (AERO). The District Election Officer Budgam has further communicated that the panch ward No: -VIII (Eight) of Panchayat Halqa Shankerpora has been fully shifted to Srinagar Municipal Corporation.

Whereas, in view of the above, the panchayat halqa Shankerpora of Block B. K Pora is now comprising of 08 (Eight) Panch Wards instead of 09 (Nine) Panch Wards and ward No:- 09 (Nine) will be figuring and read as Ward No:- 08 (Eight).

Therefore, in view of the above, the draft exercise of de-notification of Panch Ward No:-VIII (Eight) of Halqa Shankerpora Block B.K Pora District Budgam, the general public through the medium of this notice is hereby informed to go through the draft proposal of de-notification of Panch ward No:-VIII (Eight) and file their objection if any with full justification within five days from the date of publication of this notice with the office of Block Development Officer B.K Pora.

A Committee under the chairmanship of **Additional Deputy Commissioner Budgam** comprising of following Officers, shall examine the objections and submit the detailed report with clear recommendations to the prescribed authority (Director Rural Development Kashmir for final disposal). No objection shall be entertained after the stipulated period.
