The promotion order shall be on the following terms and conditions:-

- 1) That the Concerned DDO shall satisfy himself that no adverse remarks which makes the promotee unfit for promotion are recorded in the service book of the promotee & in case any such thing comes into his notice, he shall not allow the promotee to join. Such matter should be brought into notice of this Directorate immediately.
- 2) That there is no case pending against the promotee in Anti-corruption Bureau / Crime Branch / RDA or any Court of Law for inquiry and adjudication.




- 3) That the concerned DDO shall draw the revised pay in the grade of promoted post of the promotees ONLY after satisfactory report from the Anti-Corruption Bureau is received by the DDO through this Directorate. Any negligence on the part of DDO of releasing the revised pay without receiving report from this Directorate shall be personal responsibility of DDO & shall be recoverable from the DDO.

The order is subject to outcome of writ petition(s), if any, pending consideration before any competent court or any inquiry before any competent committee.
