Sanction is hereby accorded to the release of funds to the tune of **Rs. 525.86 lakhs (Rupees Five Crore Twenty Five Lakh Eighty Six Thousand only)** in favour of **Directorate of Rural Development Jammu/ Kashmir** through **BEAMS** as 2<sup>nd</sup> installment under CSS-DRDA Administration Scheme under different detailed heads as per **annexure "A"** and **annexure "B"** for its utilization during the year 2018-19 by the DRDAs of the State.


The sanction is subject the following conditions:

1. The expenditure shall be made strictly as according to the classification under which funds have been authorized by the Finance Department.
2. Treasury Officer shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
3. DDO shall complete all the codal formalities before the presentation of bills at the Treasury.
4. Treasury Officer shall not allow parking or drawal of funds in the Civil Deposit without the prior concurrence of the Finance Department.
5. The Directorate shall furnish the status report about the scheme in terms of physical and financial progress made during the current financial year.
6. The Directorate shall furnish the Utilization Certificate (UC) of the funds as early as possible and positively before 31.03.2019 to the GoI under intimation to the Administrative Department.
7. All the sanctions/ approvals and clearances shall be in place before drawal of money from the treasury.
