- 6. The DDO will operate funds strictly under rules. The leave sanctioning authority/DDO shall ensure that the claim of the cash in lieu is drawn on or after the date of retirement and not before the date of retirement.
- 7. The DDO himself will be responsible for the calculation of the cash in lieu of leave salary with reference to the earned leave at credit of the retire.
- 8. If there is any case against any of the retire including in the sanction order pending in the department/vigilance department/court of law, in such case payment shall not be released till outcome of the case/orders from this office.
- 9. The expenditure shall be restricted to the allotment shown above.
- 10. Certificate to the effect that the cash in lieu was not drawn/paid to the retiree/earlier till date should be recorded on the bill.
