Sub: - Payment of cash in lieu of leave salary for migrant employees.

It has been brought to my notice that in certain departments / offices, migrant employees have been or are being paid cash equivalent of leave salary for unutilized earned leave taking recourse to the Government Orders of GAD of 1991, without ascertaining their entitlement or admissibility.

- 2. With a view to ascertaining the number of migrant employees as have been paid cash in lieu of leave salary upon their retirement by their respective offices, Secretary, DM&RRR will compile data on:
  - (i) Number of migrant employees in various offices, both retired and in-service, (only the numbers)
  - Number of retired migrant employees as have been paid leave encashment,
  - (iii) Number of employees out of (i) and (ii) above as have been/were put on regular assignments or alternate assignments after their migration in 1990s.
- 3. Secretary, DM&RRR will complete the exercise by <u>25.04.2019</u>. For facility of convenience, an appropriate proforma can be worked out for the purpose.
