Subject:- **Theme based Audit on the topic "Management of Banks Accounts in Government Departments"-explanation thereof.**

Whereas, Administrative Department vide letter No.RDD/Acctts/TBA/2019/52 dated 12-09-2019 had sought the information of the Bank accounts for preparation of "Management of Banks Accounts in Government Departments" for incorporating the same in Comptroller & Auditor Generals Audit report;

Whereas, in compliance to above, this office vide letter No. DRDK/Bill Sec/26318-517 dated 01-10-2019 sought the said information from DDOs viz. Project Officers Wage Employment (ACDs)/District Panchayat Officers/Executive Engineers (REWs) and Block Development Officers;

Whereas, the said information was not submitted by concerned DDOs and this Directorate vide another letter No. DRDK/Acctt/8244-8443 dated 15-02-2020 requested the concerned officers to furnish the said information without any delay by or before 17th February 2020 so as to enable this office to consolidate and forward the same to Administrative Department;

Whereas, during the review meeting held at this Directorate on 15-02-2020, all ACDs made a commitment with regard to submission of above said information pertaining to their concerned district, duly consolidated, within stipulated time;

Whereas, this office vide letter No. DRDK/Acctts/9023-32 dated 17-02-2020 had requested all ACDs to depute concerned dealing Assistants to this Directorate on 18-02-2020 for submission of requisite information pertaining to their districts. However, all ACDs have miserably failed to comply;

Whereas, the Administrative Department is pressing hard for submission of said information and due to non-compliance of orders by ACDs, this office is not in position to forward the said information to the concerned quarters. Even the undersigned had to repeatedly call the District Officers for submission of instant information;


Whereas, it has been observed that all subordinate offices of this Directorate have adopted an approach of submission of "**no or delayed information**" to this office as and when requested for, resultantly this Directorate and the Administrative Department has taken a very serious note for non-compliance of various directions.

Whereas, this negligent and casual approach of sub-ordinate offices of this Directorate shall not be tolerated under any circumstances and disciplinary action under Conduct Rules shall be initiated against the derelict officers / officials.

Now therefore, in view of above, all Project Officers Wage Employment (ACDs) of Kashmir Division are hereby directed to explain their position with regard to non-compliance of directions issued by this office and non-submission of information whenever requested for. Further they shall explain as to why adverse remarks shall not be reflected in their annual performance reports/ service records and as to why their salaries shall not be withheld for non-compliance of directives issued by this office.

Further the salary of following officials shall remain withheld till further orders:-
