Sanction is hereby accorded to the release of further funds under Revenue Component for the year 2020-21 as per details given hereunder:-

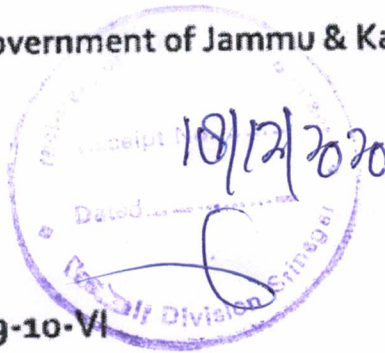
Detailed Head / Sector	Proposed %age of BE 2020-21 to be authorized (including previous authorization)
All Detailed Heads except 003-Leave Travel Concession (LTC), 046-Purchase of Vehicles, 054- Furniture & Furnishings, 104- Land Compensation, 311-Cost Price of Food Grains and 411-Refund of GST which shall be dealt on case to case basis.	90% of BE 2020-21
028-Grant-in-Aid to ULBs/ Autonomous Institutions/ Universities etc.	75% of BE 2020-21

Sanction is also accorded to the relaxation of the expenditure restrictions imposed in view of Covid-19 Pandemic vide Circular No. FD-VII-Gen (110)2009-10-II dated 29-04-2020 followed by Circular No. FD-VII-Gen (110) 2009-10-II dated 09-07-2020 and the expenditure guidelines shall now be as under:-

- (i) There shall be no restrictions on the extent of expenditure. However expenditure shall be restricted to the extent of funds authorized by the Finance Department.
- (ii) LTC (Leave Travel Concession) expenditure shall not be made without the prior consent of Finance Department.
- (iii) Transport allowance shall not be drawn in respect of employees who have not attended the office during the Covid-19 Pandemic.

The sanction is subject to further conditions as laid down in the BEAMS release order.




