In terms of the J&K Compassionate Appointment Rules 1994, notified vide SRO-43 dated:- 22-2-1994, sanction is hereby accorded to the temporary appointment of **Mohammad Shafi Dar S/o Mohammad Sultan Dar (Ex-Helper) R/o Banyari Shikari Sudnara Hastikhan as Plantation Watcher in the pay level –SLI of (Rs.14800-47100)** (Revised) in District Cadre Bandipora and adjusted under Open Category to which he belongs pursuant to SRO 294 of 2005 dated 21.10.2005.

The appointee shall report to Project Officer Wage Employment (ACD) Bandipora for further posting in the District against identified available post within a period of 21 days from the date of issue of this order and in case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled **ab-initio** without any further notice. The Project Officer Wage Employment (ACD) Bandipora shall allow the appointee to join only, on the production of following documents/certificates in original to be verified subsequently:-

- 1 Date of birth certificate
- 2 Education Qualification certificate
- 3 Domicile certificate issued by competent authority.
- 4 Health certificate issued by the Chief Medical Officer.
- 5 Dependant certificate issued by the Assistant Commissioner Revenue.
- 6 No loan certificate under Self Employment scheme from DIC and concerned Employment Department.
- 7 Any other certificate as required under rules.

The appointee shall be initially on probation for a period of two years. In case, on verification if , any of the certificates or supporting documents required under SRO-43 produced by the appointee are proved to be fake or forged or if the adverse report with reference to Character and Antecedents is received from Inspector General of Police (CID), his appointment shall be cancelled **ab-initio**.

The salary of the appointee shall be drawn and disbursed only after satisfactory report about the verification of his certificates is received from the concerned quarters and nothing adverse with reference to Character and Antecedents is received from the Inspector General of Police (CID).
