- 7. Any other Certificate as required under rules.

The appointee shall be initially on probation for a period of two years. In case, on verification, any of the certificates produced by the appointee is proved to be fake or forged or if the adverse report with reference to Character and Antecedents is received from Inspector General of Police (CID), the appointment shall be cancelled **ab-initio**.
