- d. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of condition (b) and (c) above is received.
- e. The appointee shall have to execute an agreement with the Government in terms of Jammu and Kashmir Kashmiri Migrants or Kashmiri Pandits (Special Drive ) Recruitment Rules, 2009 notified vide SRO 412 Dated.30/12/2009 read with SRO 425 Dated; 10/10/2017.
- f. The appointment shall also be subject to the writ petition(s), if any, pending before any court of law.
