Sanction is hereby accorded to the release and transfer of funds to the tune of Rs. 129.09 lacs (**Rupees One Crore Twenty Nine Lac Nine Thousand**) only in favour of DRDA's Kashmir as Grant-in Aid through PFMS on account of 2nd installment of Central share for the year 2019-20 for implementation of DRDA, Administration Scheme as per Annexure "A" to this order.

The sanction is subject to following conditions;


1. *Accounts Officer, Rural Development Department, Kashmir shall transfer the funds into the official account of the concerned DRDAs through PFMS immediately.*
2. *The Project Officers of DRDA shall observe all codal formalities while incurring the expenditure to maintain the financial discipline.*
3. *The funds shall be utilized purely for drawal of salaries of regular & genuine employees against sanctioned strength of posts and no arrears whatsoever be paid out of the released funds*
4. *The Project officers of DRDAs shall utilize these funds strictly as per the ratio fixed for salary/ other components after fulfilling the other terms & conditions under the guidelines of DRDA, Administration Scheme and no re-appropriation/diversion is allowed at any level.*
5. *That funds shall be utilized strictly as per provision of Circular issued by Finance Department vide No. FD-VII-Gen (110) 2009-10-11 dated;- 29.4.2020 No. FD-VII-Gen (110) 2009-10-11 dated;- 9.7.2020 and No.FD/VII-Gen (110)2009-10 dated;- 4.9.2020*
6. *The Project Officers of DRDA's shall immediately submit expenditure statement/utilization certificate to the Administrative Department by or before 10th of every month.*


