- 1. The funds are not diverted from one unit of appropriation to another and shall not exceed under any circumstances.
- 2. The expenditure shall be restricted to the allotment and shall be incurred after observing all codal formalities/financial rules and instruction issued from time to time by the Finance Department. The excess over the allotted funds shall in no case be entertained.
- 3. The funds shall be utilized purely for drawal of salaries of regular & genuine employees against sanctioned strength of posts.
- 4. Sanction/approval of competent authority be sought wherever required for before making payments.
- 5. The instruction conveyed vide Govt. order No.288-F of 2018 dated; 22.6.2018 be adhered to strictly before releasing the salary.
- 6. The instruction conveyed vide Govt. order No.342-F 2018 dated; 2.8.2018 be adhered to strictly be releasing the salary.
- 7. That all the amounts covered under the rules such as 7<sup>th</sup> pay installment arrears/DA arrears are paid out of the salary allotment and no liability is carried forwarded for the next financial year 2020-21
- 8. No further release of funds shall be made unless the monthly expenditure the drawal expenditure statement is regularly forwarded by 10th of the following month in this Directorate, for monitoring of the expenditure.
