- Their appointment shall be governed by Government order No. 391-F of 2019 dated 11-07-2019 issued by Finance Department J&K.
- 3. The salary of the appointees shall be drawn in terms of SRO 202 dated 30th June 2015 read with S.O. 192 & 194 dated 17th June 2020 issued by General Administration Department J&K. During the first period of two years, the appointees shall be entitled to minimum scale of pay along-with with grade pay applicable to the post.
- 4. The appointees at the time of joining shall produce following testimonials in original to be verified by the concerned DDO from respective issuing authorities and the salary be released only after receipt of satisfactory verification reports in this regard:
