
In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22-02-1994 and on the basis of documents furnished by Project Officer Wage Employment (ACD), Baramulla vide above referred communications, sanction is hereby accorded to the temporary appointment of Shri Ajaz Ul Rashid S/O Late Abdul Rashid Bhat (Ex-Panchayat Inspector) of Block Baramulla R/O Nadihal, District Baramulla under SRO-43 of 1994, as **Village Level Worker (VLW)** in the pay structure of **Rs. (19900-63200) level-2** in District Cadre Baramulla and his appointment is adjusted as per SRO-294 of 2005 dated 21-10-2005 in the Roster against **Open Category** to which candidate belongs, as reported by Tehsildar Baramulla.

The appointee shall report to Project Officer Wage Employment (ACD), Baramulla for further posting in Block Baramulla against identified post of VLW, within a period of 21 days from the date of issuance of this order and in case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice. The Project Officer Wage Employment (ACD) shall allow the appointee to join only on production of following documents / certificates in original to be authenticated / verified subsequently:-

1. **Date of Birth Certificate.**
2. **Education Qualification Certificate (Graduation Certificate).**
3. **Domicile Certificate issued by competent authority.**
4. **Health Certificate issued by the Chief Medical Officer.**
5. **Dependant Certificate issued by the competent authority.**
6. **No Loan Certificate under Self Employment scheme from DIC and concerned Employment Department.**
7. **Any other Certificate as required under rules.**

The appointee shall be initially on probation for a period of two years. In case, if on verification, any of the certificates produced by the appointee is proved to be fake or forged or if the adverse report with reference to Character and Antecedents is received from Inspector General of Police (CID), the appointment shall be cancelled ab-initio.

The salary of the appointee shall be drawn and disbursed only after satisfactory report about the verification of his certificates is received from the concerned quarters and nothing adverse with reference to Character and Antecedents is received from the Inspector General of Police, (CID).
