Subject:- Termination of services of Shri Ajaz Ahmad Bhat S/O Late Nazir Ahmad Bhat R/O Kullar, Tehsil phalgam, District Anantnag, Village Level Worker (VLW) of Block Pahalgam.

ORDER NO: 228 DRDK OF 2021

Whereas, Shri Ajaz Ahmad Bhat, S/O Late Nazir Ahmad Bhat, R/O Kullar, District Anantnag, was appointed as Village Level Worker (VLW), on compassionate basis under SRO-43 in District Anantnag, in the year 2016, vide order No. 878-DRDK of 2016 dated 20-05-2016 issued by Director Rural Development Kashmir;

Whereas, Project Officer Wage Employment (ACD), Anantnag vide communication No. ACDA/Estt/2020-21/12494-96 dated 26-12-2020, reported that said VLW has remained un-authorizedly absent from his legitimate duties since June 2020 without proper permission from the competent authority;

Whereas, said VLW was served notice by the Block Development Officer, Pahalgam vide No. BP/Estt/2020-21/289 dated 27-06-2020, delivered on his residential address, asking therein to resume his duties;

Whereas, said VLW failed to resume his duties and subsequently, the Block Development Officer, Pahalgam served another notice to the said VLW vide communication No. BP/Estt/2020-21/425 dated 27-07-2020;

Whereas, 3rd notice was also issued by Block Development Officer Pahalgam, vide communication No. BP/Estt/2020-21/599-601 dated 04-09-2020, wherein said VLW was impressed to resume his duties otherwise process for termination of his services shall be initiated;

Whereas, instead of resuming his duties, the said VLW applied for extra ordinary leave from 15-09-2020 to 12-12-2020, submitted through some of his family members, however, the said applied leave was rejected, as the said VLW was already un-authorizedly absent from his legitimate duties since June 2020;


Whereas, Block Development Officer, Pahalgam vide office communication No. ACDA/Estt/2020-21/9353-55 dated 16-10-2020, issued 4th notice through local Daily Newspapers i.e. Kashmir Uzma and Rising Kashmir published on 13-11-2020 directing him to report back to his duties, but no response was received from said VLW;

Whereas, this Directorate issued final show cause notice to the said absconding VLW vide communication No. DRDK/Estt/PF/02/VLW/2021/3730-34 dated 18-01-2021, through Local Daily Newspapers which was published in Daily Rising Kashmir and Daily Aftab on 20-01-2021, wherein final opportunity was provided to him to resume his duties within 7 (seven) days from the issuance of the final notice, failing which his services shall be terminated in terms of Article-128 of J&K, CSR without further notice;

Whereas, Block Development Officer, Pahalgam was also directed that final notice issued by this Directorate vide communication dated 18-01-2020, be served to the concerned VLW on his home address and report regarding his resumption of duties after expiry of 7 (seven) days from the issuance of final notice may be communicated to ACD Anantnag and a copy to this Directorate as well;

Whereas, Project Officer Wage Employment (ACD), Anantnag, vide communication No. ACDA/Estt/2020-21/15332-33 dated 03-02-2021, intimated that Block Development Officer, Pahalgam vide communication No. BP/Estt/2020-21/1468-70 dated 30-01-2021, has reported that final show cause notice served upon said VLW was delivered on his home address against the proper acknowledgement and further added that said VLW is still absconding and never bothered to resume his duties and accordingly ACD Anantnag has submitted the instant case file for further course of action in terms of Article-128 of J&K CSR.

Now, in view of the above and on the report submitted by Project Officer Wage Employment (ACD), Anantnag vide communication No. ACDA/Estt/2020-21/15332-33 dated 03-02-2021 and in terms of Article 128 of J&K CSR **the appointment of Shri Ajaz Ahmad Bhat S/O Late Nazir Ahmad Bhat R/O Kullar, Tehsil Pahalgam, District Anantnag, as Village Level Worker (VLW) District Cadre Anantnag of Block Pahalgam, is hereby terminated w.e.f. 1st of June 2020.**
