- 5. The appointees shall also produce NOC from Employment Department and District Industries Centre and Health Certificate duly issued by concerned Chief Medical Officer.
- 6. The appointees shall be imparted training in terms of Schedule-I to Government order No. 391-F of 2019 dated 11-07-2019 issued by Finance Department J&K.
- 7. The appointees shall be on probation for a period of two years and completion of probation period shall be subject to successful completion of training modules and passing of the related examination.
- 8. The cadre/transfer / performance appraisal of the above appointees shall be governed by Government order No. 373-F of 2019 dated 27-06-2019 issued by Finance Department J&K.
- 9. The appointment shall be deemed to be cancelled if at any stage it emerges that the certificates/testimonials produced by the candidate are fake or forged.
- 10. The seniority of the members of cadre shall be regulated under J&K Civil Services (Classification, Control and Appeal) Rules, 1956 and shall be fixed in accordance with the merit obtained by them in Panchayat Accounts Assistants Examination on the date of their passing.
- 11. The appointments will also be subject to the outcome of the writ petitions, if any are pending in any Court of Law.
