Subject: Advisory on Covid-19 response and steps to be taken in SPMRM Clusters

The surge in Covid-19 cases and the high test positivity rate across the States/UTs leading to the faster spread in the community has severely impacted the lives, livelihood, transportation and supplies across the country. The Government of India, State Governments, District administration and supplies are collectively taking necessary steps to strengthen the response.

- 2. Keeping in mind the guidelines issued by Ministry of Home Affairs, Ministry of Health & Family Welfare, by the respective State/ UT/ District Administration, the following are some further suggestive actions that may be considered to be undertaken in Rurban Clusters depending on the need and context:
 - i. Championing of taking vaccine by PRI members / SHG representatives as well as clarifying all misconceptions about the vaccine.

ii. Testing facility at the gram panchayat level / Arrangements for immediate tests for suspected cases with help of ASHA /ANM to avoid unnecessary travel and controlling further spread.

iii. All communication mediums such as local radio, local online media, social media handles and chat applications at block/cluster level etc.to be used extensively to broadcast Covid-19 appropriate behavior, immunity increasing measures, treatment protocol, vaccination related FAQs, local helpline numbers and local support networks etc.

 SHGs / ANM / ASHA to be mobilized for distributing of immunity building supplements such as Vitamin C, Zinc, AYUSH recommended herbs etc.

v. Converting some of community infrastructure into isolation centres with provisioning of regular medical practitioners. SHGs may supply cooked food to such isolation centres and other institutional spaces such as hospitals.

vi. Extensive involvement of local Civil Society Organizations in supporting the response

vii. Similarly structures made at suitable location in the village may temporarily be used for above purposes.
