- 2. The funds shall be utilized as per the Govt Order No;-117-F of 2021 Dated;-31.3.2021
- 3. The instruction of the Finance Department as laid down in Govt. Order No. 269-F of 2011 dated: 23-11-2011 may be adhered to strictly while releasing funds/incurring expenditure.
- 4. The DDO will ensure that the funds released are utilized on works in such a way that the whole irrigation & flood system runs smoothly during the season.
- 5. The allotment of funds should not be construed as an authority/approval for incurring of any expenditure in violation of codal provision, financial rules and instructions issued by the Govt. from time to time.

- 6. That the works against which the expenditure is incurred are administratively approved & technically sanctioned by the authority to do
- 7. That the works against which the expenditure is incurred from part of the current year approved ARD/Works programme.
- 8. The adequate financial/technical checks are exercised with regard to quality, specification and standard of the work before entertaining the claim for payment.
- 9. That the sanction of competent authority is obtained in case of claims barred as per J&K limitation act.
- 10. The funds are not diverted from one unit of appropriation to another and shall not exceed under any circumstances.
- 11. That the drawing & disbursing officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending.
- 12. The expenditure should be incurred uniformly throughout the year to avoid any rush of expenditure in one or more months.
- 13. Expenditure be made by concerned PRI in consultation with concerned territorial Executive Engineer of Irrigation Department for the respective areas.
