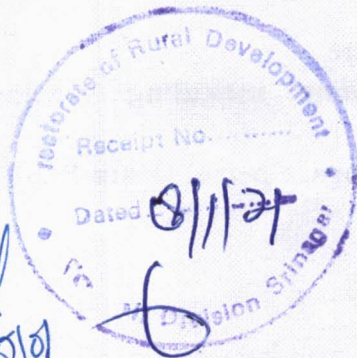

Madam / Sir,

As you are already aware and abreast of current covid-19 pandemic situation, this has posed an unprecedented challenge to the global community as well as to India. In India through our resilient health systems, tireless efforts of COVID warriors and active participation of the citizens; the impact of this pandemic has been kept far below the expected levels which were predicted during the initial phase.

2. As informed by the Ministry of Health & Family Welfare, in the context of a safe and effective vaccine for COVID-19 being available in near future, the preparations for its roll-out need to be with prior concerted planning and execution. The National Expert Group on Vaccine Administration for COVID-19 (NEGVAC) has recommended prioritization of this vaccine during the initial Phases to health Care Workers, Front Line Workers, Persons aged 50 years and above and those below 50 years of age with comorbidities.

3. A programme of this scale is not possible without pro-active support of Panchayats. Your support at the level of state and districts will be required for the following activities for roll-out of COVID-19 vaccine:

- (a) ensure registration of Health Care Workers working in health facilities under Zila Parihada/Panchayat
- (b) identification and Planning for vaccination site
- (c) support in organizing vaccination sessions including vaccine site preparation and logistics
- (d) create awareness through community meetings, Special Gram Sabhas and messages to PRIs

4. I request you to direct the concerned officials in your States/UTs for their active support in the afore-mentioned activities and make the effort a grand success for better and healthy future of Panchayats.
