The concerned Block Development Officer shall assign charge of 2-3 contiguous Panchayat Halqas to afore mentioned appointee.

The appointment of above candidate shall be subject to following terms & conditions:-


- The appointee shall report to concerned Block Development Officer within a period of 21 days from date of issuance of this order failing which his appointment shall be deemed to have been cancelled without any notice in terms of Circular No: 08-JK (GAD) of 2019 Dated 04.12.2019 issued by General Administration Department, J&K.
- His appointment shall be governed by Government order No. 391-F of 2019 dated 11-07-2019 issued by Finance Department J&K.
- The salary of the appointee shall be drawn in terms of SRO 202 dated 30th June 2015 read with S.O. 192 & S.O. 194 dated 17th June 2020 issued by General Administration Department J&K. During the first period of two years, the appointee shall be entitled to minimum scale of pay along-with with grade pay applicable to the post.
- The appointee at the time of joining shall produce following testimonials in original to be verified by the concerned DDO from respective issuing authorities and the salary be released only after receipt of satisfactory verification reports in this regard:-
 - Domicile Certificate.
 - Date of Birth Certificate.
 - Qualification Certificate(s).
 - Category Certificate, if any.
- The appointee shall also produce NOC from Employment Department and District Industries Centre and Health Certificate duly issued by concerned Chief Medical Officer.
- The appointee shall be imparted training in terms of Schedule-I to Government order No. 391-F of 2019 dated 11-07-2019 issued by Finance Department J&K.
- The appointee shall be on probation for a period of two years and completion of probation period shall be subject to successful completion of training modules and passing of the related examination.
