Your Majesty,

I being a lawyer feel that it is my responsibility to bring to your kind notice the following few facts which are related to the public at large:-

- 1. That we generally find that the departments i.e. Police, Health, Food & Supply, Electricity, PHE, Social Welfare etc. whose services are urgently required by the public have not uploaded their e-mail ids on public domain intentionally just to evade from the pressure which they will face if the e-mail ids are made available on public domain. And in some cases, though we find that the officers of some departments have uploaded their e-mails ids purposely with a very little mistake i.e. cama (,), full stop (.), dash(-), under score ( \_ ) etc. just to harass the public and make their duties much easier as per their convenience.
- 2. That just few minutes ago I had sent an e-mail to your honour which is related to the contempt of court's order obtained by my client viz. Shri Sansar Chand, resident of Maralia, Miran Sahib, Jammu from the Ld. Court of the Additional Civil Judge (Junior Division), R.S.Pura, Jammu. I didn't find the e-mail id of the concerned Police Station on public domain to mail complaint of my said client; as a result I am obliged to make this representation before your honour with a hone that a concrete solution would be established to solve the issue which is related to the public at large.

That keeping in view the above facts it has become very necessary to upload the e-mail ids and even cell phone numbers of the concerned / competent authorities of all the departments to enable the public-in-general to have prompt and/or instant approach to the authorities if needed to solve their grievances.
