In reference to earlier guidelines/instructions with regard to transfers/postings of Panchayat Secretaries issued from time to time vide this Department's letter of even No. dated 16.09.2022 followed by Govt. Order No. G.O.No.29-JK (RD&PR) of 2022 dated: 18.10.2022 and subsequent letter dated 07.11.2022, it is hereby ordered that any transfer/attachment made in violation of the said transfer policy and subsequent clarification issued in this regard stand immediately cancelled.

If any Panchayat Secretary is found still working at the place in violation of this order, shall be immediately suspended and disciplinary action shall be initiated against the concerned ACD/BDO for issuing such order.

It is further ordered that Director Rural Development Jammu/Kashmir to immediately take action in this regard and ensure strict compliance.
